### **Feedback Analysis Report**





# **POST- ANALYSIS SUGGESTIONS AND ACTION TAKEN :**

### **Suggestive Measures:**

- 1. ICT facility in the institution needs to be upgraded as per present requirement.
- 2. Curriculum development procedure needs to be in accordance with the students' current needs and employability.
- 3. Infrastructure facility in the college needs to be improved.
- 4. To foster a research ecosystem in the institution to enhance research quality and output.

### **Action Taken:**

- 1. E-learning facilities are available and teachers engage online classes and upload study material through Google classrooms. Webinars, workshops, Faculty Development Programmes etc. are also organised in online mode for which LAN/Wi-fi facility is provided in all departments.
- 2. Curriculum design and development is the domain of the affiliating university, where the institution has limited intervention. However, the teachers incorporate current trends and needs during course delivery to make these courses more relevant in today's context. Greater thrust is placed on online & e-resources available for students to widen their knowledge base.
- **3.** The Infrastructure Development and Maintenance Committee identifies and recommends the requirements and needs for maintenance of physical, academic and IT facilities. The recommendations are prioritised and implemented in a phased manner.
- **4.** The Research & Development Cell has been duly constituted to promote research activities in the institution. The IQAC has formulated clear-cut guidelines for UG & PG Research projects to streamline the procedure and submission of projects.
