And

**Christ Church College, Kanpur**

(The Mall, Kanpur)

### *1. Preamble*

This Memorandum of Understanding (MoU) is entered into by and between:

All India Women's Conference (AIWC), Kanpur Branch, a pioneering non-profit organization with a distinguished history of working towards the welfare, empowerment, and rights of women and children, and

Christ Church College, Kanpur, an institution of higher education committed to academic excellence, holistic student development, and fostering a sense of social responsibility and active citizenship among its students.

This collaboration is established on a foundation of shared values and a common vision to enrich the student experience by integrating meaningful community engagement into the campus culture. This partnership aims to create structured platforms for students to contribute to societal development and gain valuable life experience.

### *2. Purpose*

The purpose of this MoU is to create a collaborative framework for undertaking joint initiatives that:

- Provide students with experiential learning opportunities to complement their academic knowledge.
- Foster a spirit of volunteerism, gender sensitivity, and social responsibility among the youth.

- Develop life skills and leadership qualities in students through engagement with real-world social issues.
- Leverage the expertise of AIWC in women and child welfare to create impactful community programs.

### ***3. Collaborative Objectives***

The specific objectives of this collaboration are to:

- Design and implement community engagement programs focused on the welfare of women and children.
- Facilitate student participation in awareness campaigns, workshops, and outreach activities.
- Enhance students' understanding of gender issues, legal literacy, and public health.
- Create a structured pathway for students to apply theoretical knowledge to practical community-oriented projects.

### ***4. Scope of Collaborative Activities***

The parties agree to collaborate on the following indicative activities, which may be expanded based on mutual agreement:

#### ***A. Awareness & Capacity Building Programs:***

- Workshops on gender sensitization, women's rights, and legal literacy.
- Sessions on mental health, well-being, and cyber safety awareness.
- Programs on health, hygiene, and nutrition for women and children.
- Environmental sustainability drives and e-waste management awareness campaigns.

#### ***B. Skill Development & Applied Learning:***

- Training workshops in essential life skills such as First Aid and effective communication.
- Using creative arts like Nukkad Natak (Street Theatre) for social messaging and public awareness.

#### ***C. Direct Community Outreach & Engagement:***

- Jointly organizing community outreach programs.
- Mobilizing student volunteers for AIWC's ongoing initiatives.

- Organizing public engagement events and awareness rallies on pertinent social issues.

### ***5. Nature of Engagement & Financial Clause***

Student participation in the activities under this MoU shall be voluntary and recognized as a valued component of their holistic development.

Christ Church College will not provide any financial assistance or funding for the activities conducted under this MoU. All costs associated with programs, resources, and expert facilitation will be borne solely by AIWC.

No fees will be charged to the students of Christ Church College for their participation in any activities under this MoU.

### ***6. Roles & Responsibilities***

#### ***A. All India Women's Conference (AIWC) Will:***

- Lead the conceptualization and design of program content.
- Provide subject matter experts, facilitators, and bear all costs for the execution of agreed activities.
- Share its on-ground expertise to ensure the programs are contextually relevant and impactful.

#### ***B. Christ Church College Will:***

- Nominate a dedicated faculty coordinator to serve as the liaison for planning and coordination with AIWC.
- Promote the opportunities among students and facilitate their registration and participation.
- Provide necessary infrastructural support (e.g., venue, audio-visual equipment) for on-campus events only, where available and feasible.

### ***7. Duration, Review & Renewal***



This MoU shall be effective from the date of its signing and will remain in force for a period of three (3) years.


The collaboration shall be reviewed annually by the designated coordinators from both entities.



This MoU may be modified or renewed for a further period based on mutual written consent.
